The Trnava Law Days offer a platform for discussions about these manifestations, even by re-opening the issue of the nature of the rule of law as such – about the scientific exactitude of its parameters and its “story” or other forms of artistic level. That’s why we have chosen the theme **Rule of law - between science and art.**

The rule of law is not only a framework of our functioning in democracy, but also an idea to which entities refer in fighting for their rights. Recently, it is however seen as specific tension between what is and what should be. Therefore, there is revived need for comeback to the essence of regulatory and value function of law. The need for return is complemented by new knowledge about us and new context of our lives.


National crises, calling for direct democracy, division of powers, creating judicial bodies, economy and labour market regulation, social rights as well as life and values protection, the rise of extreme political movements or digital security are only a few expressions of our times to which law must respond, if it is to perform its role. Rule of law is in the background of such functioning. The 2018 conference is to hold the competence of law of the rule of law to respond to changeability of the current external context. In the effort to empower international dimension of scientific cooperation, the Faculty of Law of the Trnava University welcomes the support in co-organising the conference from *the Faculty of Canon Law, Salesian Pontifical University, Rome; Faculty of Law, Uzhorod National University, Uzhorod; the Faculty of Law, Canon Law and Administration, John Paul II Catholic University of Lublin and the Faculty of Law, Moscow State Regional University, Moscow.*
